Notice is hereby given pursuant to Chapter 551, Texas Government Code, and Chapter 49, Texas Water Code, that the Board of Directors of Denton County Fresh Water Supply District No. 7 will hold a regular meeting on Thursday, December 13, 2012, at 4:00 p.m. at 2650 FM 407 E, Suite 125, Bartonville, Texas, for the following purposes:

1. Determination of quorum and Call to Order (DW);

4. Consider approval of "agreed procedures" audit relative to the proposed disbursement of proceeds of the District's \$5,250,000 Unlimited Tax Utility Bonds, Series 2012 (the "Bonds"), and authorizing disbursement of Bond proceeds to developers and consultants in accordance with same (CC);
5. Consider and act upon authorizing execution of an Amendment to the District's Amended and Restated District Information Form relative to the Bonds (CC);
6. Consider approval and acceptance of Conveyances of Utility Facilities, Receipts and Releases relative to utility facilities to be purchased with Bond proceeds (CC);
7. Consider review and approval of minutes of November 8, 2012, Board of Directors meeting (DW);
8. Consider appointment of new director to fill vacancy on Board of Directors(CC);
9. Consider Statement of Appointed Officer, Oath of Office, and Affidavit of new Director (CC);

11. Consider authorizing preparation of District Registration Form to reflect elected/appointed supervisors and their terms of office (CC);
