Barricades will be delivered to the applicants address the business day prior to the event and picked up the following business day. Applicant is responsible for setting out barricades and removal after the event.

As an applicant I agree to provide an attendant at least 18 years of age, and competent to move barricades in the event of an emergency requiring access to/or from the block party area at all times during the street closure.

No vehicles or anything other than the barricades provided by Lantana may be used or situated to block traffic from the block party area.

Any items placed in the street including but not limited to chairs, tables, coolers etc. shall be placed on (1) side of the street leaving the other side open for emergency travel.

Any applicant violating these permit guidelines will not be eligible to be an applicant or have their home included within the area of future block parties unless specifically approved by the Board. The Board may reinstate someone's eligibility if the applicant demonstrates they took reasonable efforts to comply with these guidelines.

"OVER"

As an applicant for a block party permit, I certify that I have read and understand all of the conditions and procedures that are required in order to obtain the permit and I agree to comply with each of those conditions and procedures.

I have notified all residents within the block party area.

I agree to indemnify and hold harmless the DCFWSD #6 & #7, and all DCFWSD #6 & #7 officers, employees, agents and representatives, from any claims (including costs of defending such claims) or damages that may arise from the occurrence of the block party or from related events.

I understand that a block party permit does not authorize violation of any laws, except to the limited extent that it allows a street to be temporarily closed in conformity with permit conditions. I also understand that a block party permit does not excuse failure to comply with orders of law enforcement personnel, firefighters or other emergency workers, and that it does not provide immunity from civil claims of third parties that are based upon damages occurring at, or in conjunction with, block party events.

**I affirm, under penalty of perjury, that the statements and representations made in connection with this application are true to the best of my knowledge.**

**All block party applications are subject to final review and approval by the General Manager.**
