

**AMENDED NOTICE OF MEETING  
DENTON COUNTY FRESH WATER SUPPLY DISTRICT NO. 7**

TO: THE BOARD OF DIRECTORS OF DENTON COUNTY FRESH WATER SUPPLY DISTRICT NO. 7 AND TO ALL OTHER INTERESTED PERSONS:

Notice is hereby given pursuant to Chapter 551, Texas Government Code, and Chapter 49, Texas Water Code, that the Board of Directors of Denton County Fresh Water Supply District No. 7 will hold a regular meeting on **Thursday, December 8, 2011, at 12:30 p.m. at 2650 FM 407 E, Suite 125, Bartonville, Texas,** for the following purposes:

1. Determination of quorum and Call to Order (JR);
2. Pledge of Allegiance (JR);
3. Public comments (JR);
4. Consider approval of audit relative to the proposed disbursement of proceeds of the District's \$5,510,000 Unlimited Tax Utility System Bonds, Series 2011 (the "Bonds"), and consider authorizing disbursement of Bond proceeds to developers and consultants in accordance with same (CC);
5. Consider and act upon authorizing execution of an Amendment to the District's Amended and Restated District Information Form relative to the Bonds (CC);
6. Consider approval and acceptance of Conveyances of Utility Facilities, Receipts and Releases, and Deeds relative to facilities to be purchased with Bond proceeds (CC);
7. Consider review and approval of minutes of November 10, 2011, Board of Directors meetings (JR);
8. Consider review and acceptance of general manager's status report, including approval of routine maintenance and repair proposals (KM);
9. Consider discussion and approval of inclement weather plan for District roadways, and the taking of any action necessary or appropriate in connection therewith (KM);
10. Consider discussion and approval of purchase of pet waste disposal stations for installation within the District at various locations (KM);
11. Consider granting of Easement to Co-Serv in Bandera Common Area 3, and the taking of any action necessary or appropriate in connection therewith (KM);

  - c) Consider approval/ratification of construction plans and specifications for Hardscape and Landscape public bid packages for Palmetto Addition (Parcel 12B);

- d) Consider approval\ratification of advertising for bids Hardscape and Landscape public bid packages for Palmetto Addition (Parcel 12B);

  - f) Consider approval\ratification of Change Order No. 3 for Palmetto Addition (Parcel 12B) for an addition of \$79,993.20;

  18. Consider approval of Petition to Denton County Commissioners Court requesting enforcement of traffic rules to District roads and status of securing execution by resident landowners (CC);
  19. Consider discussion regarding action(s) regarding pedestrian/vehicle congestion at Stacey Lane and Lantana Trail, and authorize necessary action in connection with same (KM);
  20. Consider discussion regarding acquisition of capital assets, and the taking of any action necessary or appropriate in connection therewith (RH);
