Notice is hereby given pursuant to Chapter 551, Texas Government Code, and Chapter 49, Texas Water Code, that the Board of Directors of Denton County Fresh Water Supply District No. 6 will hold a **SPECIAL meeting on Thursday, July 11, 2013, at 5:30 p.m. at 2650 FM 407 E, Suite 125, Bartonville, Texas,** for the following purposes:

1. Call to Order;
2. Public comment(s) -- In accordance with the Open Meetings Act, Directors are prohibited from acting on or discussing any items brought before them at this time. Citizen's comments will be limited to 3 minutes. Comments about any of the agenda items are appreciated by the Board of Directors and may be taken into consideration at this time or during that agenda item. Please complete a Public Input Form if you desire to address the Board. All remarks and questions addressed to the Board shall be addressed to the Board as a whole and not to any individual member thereof;
3. Consider general manager's monthly status report, including approval of routine maintenance and repair proposals;
4. Consider review and acceptance of developer's report on lot and homes sales and move-ins;
5. Consider report from Finance Committee regarding development of recreational projects and venues, and parks and open space maintenance for Lantana;
6. Consider report from Safety Committee regarding actions necessary to safety and security within Lantana; acquisition and installation of traffic control devices and signage; construction of pedestrian tunnels; and retaining peace officers for cross walk management;
7. Consider extension of hike and bike trails, review and approval of plan for trail extension, and the taking of any action necessary or appropriate in connection therewith;
8. Consider discussion regarding feasibility of acquisition and construction of District building/vs. long term lease of present location or alternate location, and the taking of any action necessary or appropriate in connection therewith;
9. Consider discussion regarding written establishment of a District Communication Protocol regarding responses to inquiries from public;
10. Consider discussion regarding emergency readiness plan for Lantana, and the taking of any action necessary or appropriate in connection therewith;
11. Consider recommendation to Denton County Commissioners Court regarding appointments to Board of Directors of Denton County Development District No. 4;

12. Consider report regarding activities of 83rd Texas Legislature and relevant legislation, and authorize action as necessary;
13. Executive Session pursuant to Sections 551.071, 551.072, 551.074, and 551.076, Texas Government Code, to consult with attorney; deliberate regarding real property; review personnel matters; and consider security devices;
