Notice is hereby given pursuant to Chapter 551, Texas Government Code, and Chapter 49, Texas Water Code, that the Board of Directors of Denton County Fresh Water Supply District No. 7 will hold a regular meeting on **Tuesday, November 18, 2014, at 4:00 p.m. at 2650 FM 407 E, Suite 125, Bartonville, Texas,** for the following purposes:

1. Determination of quorum and Call to Order (DW);
2. Pledges of Allegiance (DW);
3. Public comment(s) – In accordance with the Open Meetings Act, Directors are prohibited from acting on or discussing any items brought before them at this time. Citizen's comments will be limited to 3 minutes. Comments about any of the agenda items are appreciated by the Board of Directors and may be taken into consideration at this time or during that agenda item. Please complete a Public Input Form if you desire to address the Board. All remarks and questions addressed to the Board shall be addressed to the Board as a whole and not to any individual member thereof (DW);
4. Consider review and approval of Minutes of October 23, 2014, Board of Directors Meeting (DW);
5. Consider general manager's monthly status report (KM);
6. Consider review and approval of quotes for the removal and replacement of 51 bollard lights along Lantana Trail generally adjacent to the pedestrian tunnels and walkways (KM);
7. Consider review and acceptance of developer's report on lot and homes sales and move-ins (Dev);
8. Consider review and acceptance of engineer's report, and the taking of any action necessary or appropriate in connection therewith (KC);

Consider review, approval and adoption of an Order Authorizing the Issuance of Denton County Fresh Water Supply District No. 7 Unlimited Tax Utility System Refunding Bonds, Series 2014; Delegating the Authority to Certain District Officials to Execute Certain Documents Related to the Sale of the Bonds; Entering Into an Escrow Agreement, a Purchase Contract, and a Paying Agent/Registrar Agreement, and Other Matters Related Thereto, With the Understanding That the Issue May Not Exceed the Principal Amount of \$ 7.2 Million, Must Generate 8% Present Value Savings and Be Executed Within a Period of Six Months (CC);

15. Consider acceptance of proposal for legislative services, including tracking, auditing, and government relations relating to legislation proposed in the 84th Session of Texas Legislature (CC);
16. Consider approval and execution of Interlocal Agreement with Texas Department of Transportation and Town of Bartonville for maintenance of landscaping and related improvements (CC);
17. Executive Session pursuant to Sections 551.071, 551.072, 551.074, and 551.076, Texas Government Code, as may be necessary, to consult with attorney; deliberate regarding real property; consider personnel matters; and deliberate regarding security personnel and devices (CC);
