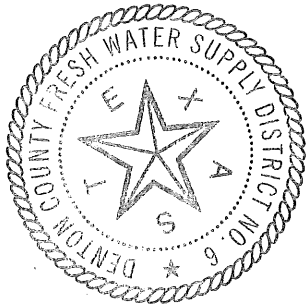

Notice is hereby given pursuant to Chapter 551, Texas Government Code, and Chapter 49, Texas Water Code, that the Board of Directors of Denton County Fresh Water Supply District No. 6 will hold a regular meeting on **Tuesday, October 20, 2015, at 6:00 p.m. at 2650 FM 407 E, Suite 125, Bartonville, Texas,** for the following purpose

1. Determination of Quorum and Call to Order (KS);
2. Pledges of Allegiance to United States Flag and Texas Flag (KS);
3. Public comment(s) – In accordance with the Open Meetings Act, Directors are prohibited from acting on or discussing any items brought before them at this time. Citizen’s comments will be limited to 3 minutes. Comments about any of the agenda items are appreciated by the Board of Directors and may be taken into consideration at this time or during that agenda item. Please complete a Public Input Form if you desire to address the Board. All remarks and questions addressed to the Board shall be addressed to the Board as a whole and not to any individual member thereof (KS);
4. Consent Items (KS):
 - a) Consider review and approval of Minutes of September 15, 2015, Board of Directors Meetings (CC);
 - b) Consider general manager’s monthly status report, including approval of routine maintenance and repair proposals (KM);
5. Consider discussion regarding water usage issues, and determination of manner by which to educate residents regarding same (KM);
6. Consider review and approval of Interlocal Agreement with Denton County for crossing guard services within Lantana (KM);
7. Consider review and acceptance of developer’s report on lot and homes sales and move-ins (DEV);
8. Consider review and acceptance of engineer’s report, and the taking of any action necessary or appropriate in connection therewith (KC):
 - a) Status of construction projects within the District, including Reata Addition project;

 - j) Miscellaneous Issues, including continuing coordination with retail developer's engineer on the retail corner design and construction;
