

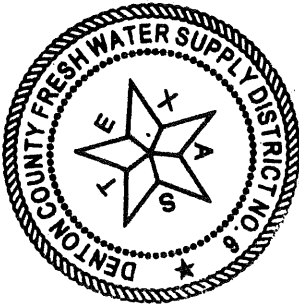
**NOTICE OF MEETING

TO: THE BOARD OF DIRECTORS OF DENTON COUNTY FRESH WATER SUPPLY DISTRICT NO. 6 AND TO ALL OTHER INTERESTED PERSONS:

Notice is hereby given pursuant to Chapter 551, Texas Government Code, and Chapter 49, Texas Water Code, that the Board of Directors of Denton County Fresh Water Supply District No. 6 will hold a regular meeting on **Tuesday, September 19, 2017, at 6:00 p.m. at 2650 FM 407 E, Suite 125, Bartonville, Texas**, for the following purpose

1. Determination of Quorum and Call to Order (KS);
2. Pledges of Allegiance to United States Flag and Texas Flag (KS);
3. Public comment(s) – In accordance with the Open Meetings Act, Directors are prohibited from acting on or discussing any items brought before them at this time. Citizen’s comments will be limited to 3 minutes. Comments about any of the agenda items are appreciated by the Board of Directors and may be taken into consideration at this time or during that agenda item. Please complete a Public Input Form if you desire to address the Board. All remarks and questions addressed to the Board shall be addressed to the Board as a whole and not to any individual member thereof (KS);
4. Conduct public hearing regarding District’s proposed 2017 tax rate (CC);
5. Consider the setting of the District’s 2017 debt and maintenance tax rates, and the adoption of an Order in connection therewith (CC);
6. Consent Items (KS):
  - a) Consider review and approval of Minutes of August 15, 2017, and September 6, 2017, Board of Directors Meetings (CC);
  - b) Consider general manager’s monthly status report, including approval of routine maintenance and repair proposals (KM);
7. Consider review and approval of amendment to District Rate Order (KM);
8. Consider review and acceptance of developer’s report on lot and homes sales and move-ins (DEV);
9. Consider review and acceptance of engineer’s report, and the taking of any action necessary or appropriate in connection therewith (KC);

  - d) Consider approval/ratification of advertising for bid(s) for water, sewer, and drainage facilities, roads, and landscape/hardscape improvements and grading;
  - e) Consider approval/ratification of award of construction contract(s)
  - f) Consider approval/ratification of Pay Applications and Change Order(s);
  - g) Consider approval/ratification of Engineering Task Order(s);

  - j) Miscellaneous Issues, including continued work requested by District and Developer;

  12. Consider approval of Texpool Logic Investment Pool as an authorized District Investment, and approval of District participation in the Local Government Investment Cooperative (LOGIC), and adoption of Resolution in connection therewith (RH);
